### **Sub.: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13<sup>th</sup> July 2023, please refer our letter dated 14<sup>th</sup> August 2023, wherein we had informed that Goods and Service Tax Authority has imposed a penalty of Rs. 4.14 lac at Gorakhpur, Uttar Pradesh, due to clerical error in mentioning Pin Code of Delivery Address on e-way Bill.

In this respect, we further inform you that the Additional Commissioner, Grade-II (Appeal)-1 of State Tax, Gorakhpur, Uttar Pradesh vide its Order dated 4<sup>th</sup> April 2024 has rejected the appeal filed by the Company by treating the said mistake as violation of provisions/rules of Goods and Service Tax Act.

The said Order had been uploaded on GST portal by the GST Department on 9<sup>th</sup> April 2024 from wherein the Company has come to know of this Order. The Company will file appeal before the appropriate authority against the said Order within the specified timeline. There is no material impact on financial, operation or other activities of the Company.
